## RELEASE OF LIABILITY AND ACKNOWLEDGMENT AND ACCEPTANCE OF DANGERS, RISKS AND HAZARDS

I hereby acknowledge that I am being permitted to participate in the activities of Indianhead Ranch, and I have read and understand the terms, provisions and conditions of participation in the activities of Indianhead Ranch and will abide by its terms, provisions and conditions.

I further acknowledge and understand that no warranty, either expressed or implied is made by the owner or management as to the condition of the property or the available activities, located in Val Verde County, Texas, including but not limited to: the number, quality, size, or availability of any particular game on any particular guided tour or hunt, and the quality or condition of any roads, buildings, gates or other improvements located on Indianhead Ranch. This document is sufficient warning that dangerous conditions, risks and hazards do exist. My presence and activities on the premises expose both me and my property to dangerous conditions, risks and hazards, including but not limited to: poisonous snakes; insects and spiders; blinds and tree stands; erosion and general condition of the land, both on and off roadways or senderos, creating rough, hazardous and dangerous driving and walking conditions; animals, both wild and domestic that may be diseased and/or potentially dangerous; deep water; person(s) with firearms both on or off the premises; and the use of vehicles. I hereby state that I expressly and unconditionally assume all such dangers, risk and hazards whether known or unknown.

In consideration for the right to enter the Indianhead Ranch premises, I hereby release and agree to protect, indemnify and hold harmless the owners of Indianhead Ranch and their respective agents, employees and assigns from and against any and all claims, demands, cause of action and damages, including attorney's fees, resulting from any accident, incident or occurrence, including death or loss of property arising out of, incidental to or in any way resulting from the use of the premises and all improvements thereon, whether or not caused by the owners' negligence or gross negligence, in whole or in part. This release applies during the time that I am permitted on the Indianhead Ranch premises and it applies to any claims of any nature arising from my visit to Indianhead Ranch. I hereby further covenant and agree that I, my heirs, successors and assigns will not make any claim or institute any suit or action at law or in equity against the owners and their respective heirs, agents, representative, employees, successors or assigns and by my signature below I hereby waive any claims against Indianhead Ranch as detailed in this release.

As used in this release, the terms I, my person and myself include minors who are with me while on the Indianhead Ranch premises.
